### Course/Module description:

In this seminar, we study critical theories of culture, focusing on traditional

approaches to the cultural genetics of power through notions of domination/resistance and authenticity/commodification, and more recent approaches claiming a more complex texture of innovation, creativity, and restructured power relations. We question the role of theory and criticism in contemporary understandings of culture, examine tensions between the theory and practice of culture, and consider how cultural theory impacts methodologies of cultural research.
