## Course/Module description:

This course will provide students with a professional framework in community-based Development. Created specially for the "Glocal Community-Development" program, this course will complement the academic courses of the program by connecting theory to practice and preparing students for their internship and future careers in the field of Community-Development.

The course focuses on two seemingly contradictory yet complementary domains. The first emphasizes the ability to improvise, to "jump in" and skillfully engage in different aspects of development work, dealing with whatever comes up and doing whatever it takes to deal with constantly changing realities. Providing the essential "tool kit" includes resources such as: Community assessment, Fundraising or IT skills.

The second section emphasizes the ability to "step back" and reflect on the situation and our actions within it. Searching for new perspectives and alternatives, developing the flexibility needed in order to adjust to the ever-changing reality of development work. This will be done by focusing on skills such as reflective and complex thinking, dialog and cross-cultural skills and their connection to community empowerment and ownership.

#### Course/Module aims:

To enable students to become better community-development professionals by: Exposing students to a variety of languages and perspectives relevant to development.

Allowing Students to use and reflect on a variety of professional tools, concepts and approaches.

Learning from past and present experience.

Acting - Reflecting - and moving on together.
