Course/Module description:

The seminar will study the elements of international law that are reflected in select documents associated with the attempts to resolve the conflict between Israel and its neighbours.

Course/Module aims:

To understand the role of international law in the Peace Process

<u>Learning outcomes - On successful completion of this module, students should be able to:</u>

Basic knowledge of modes of acquisition of territory; use of force; laws of war; law of sea; elements of treaty law; powers and procedures of UN bodies.

Teaching arrangement and method of instruction: The first part of the course will be lectures by the teacher. During the second part, students will be asked to present their chosen topic orally in class (not more than twenty minutes presentation) the presentation must be in English.

Course/Module Content:

The seminar will study the elements of international law that are reflected in select documents associated with the attempts to resolve the conflict between Israel and its neighbours. Among the documents to be studied: The 1917 Balfour Declaration; The 1922 League of Nations Mandate for Palestine; The 1949 Armistice Agreements; UN General Assembly Resolutions 181 and 194. UN Security Council resolution 242. The 1968 Camp David Agreements; The 1969 Peace Agreement with Egypt; The 1993 Oslo Agreements; The 1994 Peace Agreement with Jordan; The Arab Peace Initiative; The Roadmap; The Palestinian Declaration of Independence; Nongovernmental recent initiatives. These documents are available on the internet including; http://www.mfa.gov.il/mfa/peace%20process/reference%20documents Associated with the study of each document, there will be a lecture and class discussion of the key elements of international law that have been relevant to the particular document. These elements include recognition of states; modes of

acquisition of territory; use of force; laws of war; law of sea; elements of treaty law; powers and procedures of UN General Assembly and Security Council.

Students will then be requested to choose a seminar topic, from a list, related to the subject of the seminar lecture to the class on the subject and submit a written

paper.
