Course/Module description:

In this seminar, we study contemporary literature in a theoretical and comparative perspective. we discuss theories of contemporaneity from the fields of philosophy, art history, and cultural studies, the question of literary innovation, and the possibility of literature to articulate the present, emergent moment in culture. we read chosen literary works to evaluate different ways in which they intervene to create changes in presence.

in the first semester, next to key theories of contemporaneity, we study the "post-hysterical" fictions of David Foster Wallace and Zadie Smith, as well as literatures of mobility and movement - of languages, people, species - by Yoko Tawada, Marie NDiaye, and Barbara Kingsolver. In the second semester, we study the interface of the literary and the digital, as well as of literature and architecture.

Course/Module aims:

to think in critical and comparative terms about the present moment in literary culture

- * debate theoretical approaches to contemporaneity
- * outline possibilities and limitations of a comparative approach to contemporary literature
- * criticize chosen works of contemporary literature
