Course/Module description:

The course deals with the concept of estrangement as formulated in Viktor Shklovsky's theory in comparison with other aesthetic approaches to the problems of defamiliarization and alienation such as those of Berthold Brecht, Mikhail Bakhtin and others. The focus of our discussion will be the question of aesthetic distance in literature, art, theatre and cinema. The analysis will be illustrated by visual materials connected to the topic.

Course/Module aims:

The aim of the course is to analyse the theory of estrangement in comparison with other aesthetic approaches to the problems of defamiliarization and alienation.

<u>Learning outcomes - On successful completion of this module, students should be able to:</u>

- 1. To acquire the necessary knowledge of the Formalist theory of estrangement and its genesis
- 2. To compare the concept of estrangement with other aesthetic approaches to the problems of defamiliarization and alienation such as Leo Tolstoy's theory of art, psychoanalysis, Mikhail Bakhtin's ideas etc
- 3. To acquire the necessary knowledge of literary and cultural development in the époque of Modernism and Avant-Garde
- 4. To enrich the acquaintance with the system of literary genres in Russian literature of the period
- 5. To equip themselves with theoretical methods and categories for the analysis of various artistic texts of the period
- 6. To improve their analytic ability as regards literature and art
