Course/Module description:

This course uses legal sources to examine the history of women, gender and sexuality in the Hispanic world between the 14th and the 17th centuries, with an emphasis on Spain and Spanish America. Throughout the semester, we will analyze a series of judicial case studies dealing with issues such as marriage and property disputes, insults and honor, sexual violence, and religious transgression. Using these cases to learn about Hispanic women and their interactions with different legal institutions, we will examine the law not only as an instrument of male domination and social control, but also as a tool used by women to deal with violence and oppression, and analyze the roles played by gender, class, and race inside the courtroom. The weekly readings include scholarly studies and primary sources, such as laws and regulations, verdicts, witness-deposition-records, petitions for royal justice, and inquisitorial records.

Course/Module aims:

The students will learn about the history of women, gender, and sexuality in the late medieval and early modern Hispanic world; The students will learn about the legal system; The students will familiarize themselves with current scholarly debates concerning these topics; The students will practice primary source analysis and develop critical reading skills.

Demonstrate knowledge of issues central to the history of women, gender, and sexuality in the late medieval and early modern Hispanic world; Demonstrate knowledge of the legal system of the Hispanic world; Demonstrate knowledge of the key questions and methodological approaches that characterize current scholarship of the said topics; Analyze late medieval and early modern legal sources and demonstrate critical reading of primary sources.
