# Course/Module description:

The course will deal with different aspects of the social and cultural history of the Middle East, from the appearance of Islam to the beginning of the modern era, with a certain emphasis on the Mamluk period (1250-1517) in Egypt and Syria. Among the topics to be discussed: Arabization, islamization, the formation of Muslim society, learning and scholarship, established religion and popular religion, sufism as a social phenomenon, cities and urbanization, waqf, the village and agriculture, etc.

#### Course/Module aims:

The seminar seeks to imbue in the students an understanding and appreciation of the wide variety and richness of medieval Middle Eastern society and culture. The student will not only learn facts (important as these are), but will gain a sense of the development of various aspects of the social and cultural history of the region, looking at its various components (different religious communities, sundry social strata, urban and rural societies, etc.). Students will be exposed to modern survey literature, specialized studies and original sources (in translation). Thus, s/he will gain training as a young historian, learning to ready critically and carefully both original sources and modern scholarly literature.

<u>Learning outcomes - On successful completion of this module, students should be able to:</u>

The student will have a richer understand of the the sweep of pre-modern Middle Eastern history, and its salient themes. S/he will gain training as a young historian, learning to ready critically and carefully both original sources and modern scholarly literature.
