Course/Module description:

This course delves into the multifaceted elements of the marital framework. The curriculum is bifurcated into two primary segments:

Comprehending the dyadic life cycle, diagnostic methodologies in couples therapy, and evaluative procedures.

Exploring advanced applications in couples therapy, including the utilization of genograms, and addressing relational conflicts and infidelities.

Course/Module aims:

Course Objectives: This course aims to provide a comprehensive understanding of the multifaceted dimensions of marital life. We will critically examine the evolution of marital relationships, influenced by cultural, sociological, and psychological determinants. Emphasis will be placed on the mechanisms that reinforce and transform marital ties, patterns of child-rearing and parenting, and the complexities associated with the dissolution of marriage. Furthermore, we will probe into the clinical perspectives, analyzing the underlying causes of conflicts within marital partnerships. The course will also review theoretical frameworks and interventions designed to assist couples navigating crisis situations.
