Students will get acquainted with two additional instruments of assessment: Rorschach

(R-PAS) and MMPI.

Course/Module aims:

Learning the theoretical foundations of the Rorschach and MMPI tests, and the administration procedures, scoring and test interpretation.

Lesson 10 - MMPI - Validity scales.

Lesson 11 - MMPI - Clinical scales.

Lesson 12 - MMPI - Content and supplemental scales. MMPI written report. Case illustration.

Lesson 13 - Case illustration of the integration of all tests. Writing the complete

psychological report.
