Course/Module description:

The European Union is a unique "beast" from political, institutional, governmental, economic and legal perspectives. It is also unique from disciplinary point of view - much more than international organization but less than a state. As such it is a challenge to researchers.

The course will examine its uniqueness since WWII until the euro and refugee/asylum and Brexit crisis today. It will explain how the EU works and analyze the change of institutional equilibrium along the years and the policy incremental transformations in the single market, euro, schengen zone and foreign and security policy.

Course/Module aims:

To develop wide knowledge and deep understanding and analysis capacity about the European integration project from historical, political-institutional, policy perspectives.

To introduce the students to major theoretical approaches analyzing the EU.

Learning outcomes - On successful completion of this module, students should be able to:

1. to define the basic terminology of European integration
2. To describe, explain, compare and analyze the ups and downs in the integration process.
3. to analyze the integration process with different theoretical tools
4. to generalize and exemplify processes and phenomena in the integration process
