Course/Module description:

Teach students the most important aspects of quadripartite occupation of Austria nation building after WW II and the origins of the Cold War in Austria. Familiarize students with political, economic, social (eg. denazification) and mental (Austrians as victims and/or perpetrators in WW II?) reconstruction (some comparisons with the occupations of Germany and Japan will be made)

Understand the concept of [nation building] & the four powers[] goals in occupying Austria

Understand the factor that contributed to the origins of the Cold War in Austria Understand domestic Austrian politics in the occupation decade, esp. the politics of the []grand coalition[]

Understand the making of the Austrian State Treaty (postwar peace treaty)
