Course/Module description:

*During the 1930's, in an attempt to cope with the severe contemporary economic crisis, the majority of European countries voted for radical ruling parties – from both extremes of the political spectrum. However, in the Nordic countries (Sweden, Denmark, Norway, Finland and Iceland – which was still part of Denmark at the time), a 'third way' gradually developed, an intermediate approach between capitalism and communism. Eventually, as a consequence of extraordinary historical circumstances, this approach was titled the 'Nordic model', and it has been characterized by several unique features: a generous welfare state, democratization of society, adult education (Life Long Learning), striving for gender and class equality, and a political decision making process based on compromise and consensus. In this class, we will explore the historical developments that have led to the creation of the Nordic model - today one of the most successful models in the world according to OECD's indices - and critically analyze its ability to cope with various up-to-date national and global challenges.*

- Exhibit basic knowledge and understanding of similarities and differences in the Nordic countries' historical development towards Welfare Regimes
- Analyze the complex cooperative relations between the Nordic countries from the beginning of the 20th century and until our days
- Assess the challenges facing the Nordic Model within the European Union as well as towards globalization processes
