The purpose of this course is to provide students with useful tools for engaging in empirical research in political science. Much of this course will involve learning statistical procedures and applying them to political data. To understand the routines that the computer performs, and to correctly interpret the results given the method's assumptions, yet a tolerance for algebra will be a necessity. Students should have taken BA-level research methods and statistics classes and understand the basics of research design, data management, and bivariate statistics.
