*Course/Module description:*

---

*The course examines the political aspects of a period of Israeli-European relations. We emphasize both bilateral relations between Israel and the leading European states such as France, Britain, and Germany, and relations between Israel and the multinational frameworks of the European Community and European Union. The course not only examines the Israeli perspective but helps students understand the European view of Israel and political issues on the agenda. The course covers a broad period of history—starting from pre-state Zionist diplomacy, the early years of the state (1950s and 60s), changes after the Six-Day War, the rise of the Palestinian question, and ending with the Oslo Agreement and its collapse, and Israel's relations with Europe today. It explores such questions as: What was Europe's relative weight in Israeli diplomacy at the time? How did non-material factors such as values, common heritage, and negative memories of the past help to shape Israeli-European relations? How did the developments in the Arab-Israeli conflict influence the relationship and how did Europe's view of Israel change during this period? What was the role of Israeli and European public opinion in shaping the relationship? and How important was the identity of the ruling parties for the relationship?*

*The course consists of frontal lectures and group assignments.*

The main emphasis will be on understanding Israel's foreign policy approach and its unique characteristics in Europe.*
