# Course/Module description:

The course examines the main developments of peace efforts in the Israeli-Arab conflict. It analyzes peace plans, negotiation processes, and agreements pursued through various tracks, from the establishment of the State of Israel in 1948 to the present (including Israel-Egypt, Israel-Jordan, Israel-Syria, and Israel-PLO). Within this framework, the course explores the impact of leaders, domestic factors, and regional and international dynamics on the diplomatic processes between Israel and the various actors in the regional arena. The course uses theoretical tools from the fields of Foreign Policy Analysis, Diplomacy, and Negotiations, to examine successes and failures of peace efforts, and the role played by different actors, and to identify trends and lessons regarding barriers and opportunities at different stages. It includes textual analysis of key diplomatic documents in the process, such as UN Security Council resolutions and agreements.

- 4. Discuss challenges, and tools that can overcome these challenges, in transition from conflict to peace, and the role of diverse actors, internal and external, in peacemaking.
