Course/Module description:

In the course, we will discuss the status, importance, and implications of words, and their related linguistic phenomena (such as narratives, metaphors, and political concepts) in international politics. We will explore different theoretical frameworks and case studies, and we will do it in an active and participatory manner, combining class discussions, and individual research, culminating in a research paper.

Course/Module aims:

In the Seminar we will discuss the status, importance, and implications of words, and their related linguistic phenomena (such as narratives, metaphors, and political concepts) in international politics. We will focus on such concepts as security, democracy, peace, and war. We will study the different attitudes to these linguistic entities among various theoretical frameworks, and we will understand the implications of these different perspectives on the practice of international politics, and its study.
