This course is designed to impart knowledge in academic research in the social science a whole and in criminological research in particular

Course/Module aims:

The course has three main sub-objectives:

- (1) Providing theoretical knowledge about research in the social sciences in general and in criminology in particular what are the main research principles, what are the main research methods and the advantages and disadvantages of each method.
- (2) Impart the students the ability to read and analyze academic research The structure of the article, the theory underlying it, the structure of the research and the research's main findings.
