## Course/Module description:

This course engages with the theoretical and practical aspects of citizenship law and policy in both the national (comparative country analysis) and international law context.

#### Course/Module aims:

By the end of this course you should be able to understand the theoretical debates about membership in a nation state and citizenship scholarship across the disciplines and how that relates to citizenship law and practice, in several countries.

<u>Learning outcomes - On successful completion of this module, students should be able to:</u>

- Understand the theoretical debates about citizenship
- Describe (orally and in written formats) how those theoretical debates link to citizenship law and practice
- Assess the elements of citizenship law in a range of countries
- Evaluate the policy issues that arise in the national and international area around citizenship

### Attendance requirements(%):

Students are expected to attend the classes and as part of their assessment they will be assessed on a presentation to the other students on some specific material allocated to them.

Teaching arrangement and method of instruction: There will be 4 classes (one each Monday) of three hours duration around the class materials set for each class. Beyond the first week, students will be allocated additional material to present to the other students as a form of class presentation/participation, within the last three, three hour class.

Citizenship as Legal Status – the Role of Constitutions; Citizenship/ Nationality Laws; Dual Citizenship; International law and citizenship/nationality; Post-national Citizenship
