Course/Module description:

The course will provide primary tools for Comparative Law research of Jewish law and ancient legal systems such as Ancient Near East law, Persian law, Roman law, Canon law, and Islamic law.

Course/Module aims:

1. Basic familiarity with the method of comparative law.
2. Familiarity with the basic principles and sources of ancient legal systems.
3. Exploring the fruit of the study comparing Jewish law and ancient legal systems.

1. Identify the appropriate legal system to compare with the texts of Jewish law from different periods and places.
2. Describe the structure of the relevant ancient legal system
3. examine the sources of the relevant ancient legal system
4. Use of the secondary literature about ancient legal systems for purposes of Jewish law research
