## Course/Module description:

The course focuses on fundamental questions concerning the revival of Hebrew speech in Israel and the diaspora at the turn of the 19th century through the first half of the 20th century. Was Hebrew a dead language? Is the revival of Modern Hebrew a creation of a new language? What are the unique linguistic characteristics of Modern Hebrew speech? What are the different types of Modern Hebrew speech?

## Course/Module aims:

Understanding the social and linguistic processes of the reveracularization and the formation of Modern Hebrew as a spoken language.

- To describe the dramatic change in the status of Hebrew and in the domain of its usage in the end of the 19th century and the beginning of the 20th century.
- To explain the difference between the term 'revival' and alternative terms for the process of nativization and vercularization of the Hebrew language.
- To compare the different approaches towards the question if Modern Hebrew is a new language.
- To Analyze the unique conditions for the success of the revival.
- To evaluate the role of different factors in the process.
- To characterize different types of foreign influences on Modern Hebrew following language contact.
