## Syllabus

The aim of the course is to study in depth a few central subjects in Islamic history religion and culture and to encourage the students to "think differently" namely to examine theories, survey the sources and question if needed their validity and their reliability. This may modify our understanding of the birth of Islam and its subsequent development.

Some of the subjects suggested for study are:

1. Muhammad, the birth of Islam and the creation of the empire: background, comparison with Christianity, examination of the sources.

2. Geography and history: contribution of the various territories that came under Islam to its early development.

*3. "Holy History" (Heiligengeschichte - hagiology) and history: Scheme and reality in the accepted story of the Islamic rule – The Calipahte, "Four righteous Caliphs," Dynasties.* 

4. Schism in Islam: The birth of the Shī'ah and other independent movements outside the so called "Consensus."

*5. "Dome of the Rock" – Symbol? Political statement? Religious Statement? Architectural examination.* 

6. War and Peace in Islam.

7. Jews and Christians under Islam.

8. Reform and renewal in Modern times.
